LICENSE COMMISSION MEETING

MINUTES OF THE MEETING

December 16, 2015

Meeting was called to order at 7:13 p.m. by Chairman Lamb.

1. Minutes of the meetings from November 18, 2015. Motion made by Commissioner Mullen to accept the minutes. Motion was seconded by Commissioner Thomas. Motion passed unanimously.
2. **Shiven, LLC d/b/a Taunton Wine & Liquors** – Approval of Section 15 Change of Sunday Hours. Detective Lt. McCabe stated that pursuant to MGL, c. 138, §15 that the licensee was entitled as a matter of right to open at 10:00 a.m. and that they do not need local licensing authority approval, but must notify the local board about the change of hours. Commissioner Mullen made a motion to approve the request for a change of hours from Shiven, LLC d/b/a Taunton Wine & Liquors. Commissioner Thomas seconded the motion. Motion passed unanimously.
3. **Taunton American Portuguese Civic Club** – Appearing before the Board is John Arruda. Chairman Lamb explains that the PACC would like to change their Sunday hours to include brunch. Chairman Lamb asked Mr. Arruda if the kitchen was run by an outside agency or if the club ran it. Mr. Arruda stated that the club ran the kitchen.

Commissioner Mullen made a motion to approve the request for a change of hours for the Taunton American Portuguese Civic Club for Sundays to open at 10:00 a.m. Commission Thomas seconded the motion. Motion passed unanimously.

4. **International Pizza, Inc.** – Status of Application. The form 43 was returned to the local licensing board for supplemental information. Mr. Figueiredo complied with the request and the local board needed to submit a reconsideration form 43. Commissioner Mullen made a motion to resubmit the form 43. Commissioner Thomas seconded the motion. Motion passed unanimously.
  
5. **TAOPB5 Restaurant, LLC d/b/a New Weir Pizza & Restaurant** – Application for a Common Victualler and an Entertainment License. Appearing before the Board is Andranik Balian and Mrs. Kalliopi Karageorgos. Mrs. Karageorgos explained that she and her husband were selling the business and that they wanted to get ahead of the game and get the paperwork switched over. Mrs. Karageorgos stated that she would stay on as the manager of the restaurant. Detective Lt. McCabe explained that if the Common Victualler application is approved this month, and the alcohol license transfer next month, then all of the money will need to be separate because it will be two separate entities. Detective Lt. McCabe further explains that ABCC approval is needed before they can sell the business. Chairman Lamb suggests that this matter be tabled until next month. Commissioner Mullen stated that in January, the Board will hear all three applications. Commissioner Mullen made a motion to table the instant matter until the Board’s January meeting. Commissioner Thomas seconded the motion. Motion passed unanimously.
  
6. **Taunton Lodge N. 150, BPO Elks of the U.S.A.** – Application for a Section 12 alcohol license. Appearing before the Board is Robert Folcik and Timothy Avelino. Chairman Lamb asked Detective Lt. McCabe if everything looked in order. Yes. Chairman Lamb asked about the sketches. Mr. Avelino stated that the sketch outlined the existing building and the proposed addition. Chairman Lamb asked how the facility would be run; would there be a member section and a public section. Yes. Mr. Folcik added that each section will have a separate bar. Chairman Lamb inquired about food. Yes. Chairman Lamb asked if the Elks would be preparing the food or another entity. Mr. Folcik stated that still needs to be determined. Chairman Lamb informed Mr. Folcik that if someone else prepared the food, then they would need to appear before the Board again. Commissioner Mullen inquired as to if there would be changes to the existing building. Only to existing walls, etc. Chairman Lamb asked where are the plans were within the City process. Mr. Folcik stated that the Elks had gone before the DIRB, they met with the Planning Board and got the zoning ordinances that they needed. They are scheduled to meet before the Planning Board

again in January. Commissioner Mullen asked what the time frame would be. Mr. Folcik stated that he hoped to break ground in January after the Planning Board meeting. Commissioner Mullen asked what the current operation was. Mr. Folcik stated nothing at the moment; they are occupying it for meetings and renting the hall out for functions. Up until the end of December, they are utilizing DeAvila's catering license. Commissioner Mullen asked about alcohol storage. Mr. Avelino indicated on the floor plan where the storage would be. Detective Lt. McCabe and Detective Smith stated they were all set with the application. Commissioner Mullen made a motion to approve the application for a Section 12 alcohol license for the Taunton Lodge of Elks pending completion of the project and conformance of drawing we have before us. Commissioner Thomas seconded the motion. Mr. Folcik asked if the approval was based on the existing facility for now until such time as the addition is built and then the Elks would come before the Board for full approval. Chairman Lamb stated that was correct.

7. **2016 Common Victualler License** - Commissioner Mullen made a motion to approve the 2016 Common Victualler licenses as presented by Detective Lt. McCabe. Commissioner Thomas seconded the motion. Motion passed unanimously.
8. **2016 Entertainment Licenses** – Chairman Lamb stated that according to the list, there were two establishments that had not supplied applications; Frank's Good Times and McGraths' Otherwise, all packages are complete. Commissioner Mullen made a motion to approve the Entertainment Licenses as presented with the exception of Frank's Good Time Lounge and McGraths Cafe. Commissioner Thomas seconded the motion. Motion passed unanimously.
9. **2016 Alcohol Licenses** – Chairman Lamb stated that there are two applications that had not been returned: Benjamins and Sousa and Lee. Detective Lt. McCabe stated that was correct. He added that seasonal licenses are good until January 15<sup>th</sup> and don't renew until April. Commissioner Mullen made a motion to approve the Section 12 licenses as presented. Those not renewing are Benjamin's and Sousa and Lee. We have a total of 48 licenses. Commissioner Thomas seconded the motion. Motion passed unanimously. Commissioner Mullen stated that there were also 24 Section 15 licenses. Commissioner Mullen made a motion to approve the Section 15 licenses as presented. Commissioner Thomas seconded the motion. Motion passed unanimously.
10. **New Business** - Chairman Lamb stated that under new business there were two pieces of communication. The first one was from Diane Wilbur dated December 9,

2015 notifying the Board of a 3 week closure. Chairman Lamb read the letter into the record. The second letter was from Regal Cinemas requesting a pro-rated 2015 license but the recording secretary informed the Board that the attorney representing Regal Cinemas wished to withdraw the letter.

Meeting dates – The following dates were scheduled for the upcoming 2016 license commission meetings: 1/20, 2/17, 3/16, 4/20, 5/18 and 6/15.

Chairman Lamb made a motion to adjourn. Commissioner Mullen seconded the motion. Meeting was adjourned at 7:27 p.m.
