Meeting was called to order at 7:00 p.m. by Commissioner Mullen

Commissioner Turner makes a motion to approve minutes to the July 20, 2022 meeting. Commissioner Mullen seconds the motion. Unanimously passed.

Old Colony History Museum at 66 Church Green – Application for a Special Alcohol Permit for September 8, 2022 from 7:00 p.m. – 9:00 p.m. and November 17, 2022 from 6:00 p.m. – 7:00 p.m. at 66 Church Green: Community Programming Coordinator Saria Sweeney is present on behalf of the applicant. For the September 8th event they are going to have a beer garden outside along with other activities and then inside will be the mobile escape rooms. Berkley Beer and Milton Wine and Spirits will be providing the alcohol and all alcohol will be removed the same day. On November 17th they will be having a wine and cheese tasting. All alcohol will be brought on and off the day of the event.

Commissioner Turner makes a motion to approve the Special Permits for Old Colony History Museum. Commissioner Mullen seconds the motion. Unanimously passed.

St. Anthony's Church – Application for a Special Alcohol Permit from 5:30 p.m. – 11:30 p.m. on September 24, 2022, November 12, 2022, February 11, 2023 and May 28, 2023 at 126 School Street: Attorney Joseph deMello present on behalf of the applicant. They are planning 4 dinners and they would like to sell beer and wine. They are trying to bring back community that they lost due to COVID. They will be purchasing from a wholesaler and the alcohol will be brought in and removed within 24 hours of the event.

Commissioner Turner makes a motion to approve the Special Permits for St. Anthony's Church for the day before and the day after for the dates of 9/24/22,

11/12/22, 2/11/23 and 5/28/23. Commissioner Mullen seconds the motion.
Unanimously passed.

TAPPED Beer Truck – Application for a Special Alcohol Permit from 2:00 p.m. – 5:00 p.m. on September 17, 2022 at 225 John Hancock Road: Matt Cohen, Chief Operating Officer for TAPPED. Private catering gig for Performance Food Service. They are having an afternoon get together for their employees and their families. The company is providing an unarmed security guard. Servers are TIPS certified. They have the rip away bracelets that will be used. They have a 12C for their food truck, but not alcohol. They've been in business for 3 years. They have 2 trucks that are outfitted with taps and they usually cater corporate events.

Commissioner Turner makes a motion to approve the Special Permit for TAPPED Beer Truck at 225 John Hancock Road in Taunton. Commissioner Mullen seconds the motion. Unanimously passed.

Old Business/New Business: Commissioner Mullen asks if there has been any word on when The National will be opening. They now have a target date of November. Commissioner Mullen states that Commissioner Mullen states that they must open this year. The license has issued for The Society, but they aren't operating as of yet.

Commissioner Turner makes a motion to adjourn. Commissioner Mullen seconds the motion.
