**Commissioner Mullen makes a motion to approve minutes to the August 17, 2022 meeting. Commissioner Turner seconds the motion. Unanimously passed.**

**Old Colony History Museum at 66 Church Green – Application for a Special Alcohol Permit for October 15, 2022 from 12:00 p.m. – 4:00 p.m.:** Community Programming Coordinator Saria Sweeney is present on behalf of the applicant. This is an application to run their beer tent at the Liberty and Union Festival. They have been holding this event for a few years now. Berkley Beer does all of their pouring and all alcohol will be brought on and off the premises the day of the event. They will be using wristbands and they will have a police detail.

**Commissioner Turner makes a motion to approve the Special Permits for Old Colony History Museum for the Liberty and Union Festival on the date requested. Commissioner Mullen seconds the motion. Unanimously passed.**

**Barbeque Integrated, Inc. d/b/a Smokey Bones Barbeque and Fire Grill, 1023 County Street – Application for a Change of Manager and Change of Hours:** Proposed Manager Herman Medeiros is present on behalf of the applicant. They would like to change the serving hours for Sundays on their license 12:00 p.m. to 11:00 a.m so that they can begin serving when they open. Mr. Medeiros is the former manager of this location and has been transferred back after managing one of the Rhode Island locations. Commissioner Turner states that Detective Rutherford reached out to him to let him know that Mr. Medeiros' background check came back with no problems and he is in support of the application.
